**FEEDING DIRECTIONS:** For 15% Ration from above Mixing Directions, hand feed continuously at a rate of 2.4 to 8.0 lb per head per day to provide 60 to 200 mg of Lasalocid per head per day. For 18% Ration from above Mixing Directions, hand feed continuously at a rate of 1.7 to 5.7 lb per head per day to provide 60 to 200 mg of Lasalocid per head per day. Do not exceed 0.30 ppm supplemental selenium in the total ration. Always provide plenty of clean, fresh water.

**WARNING:** A withdrawal period has not been established for this product in pre-ruminating cattle. Do not use in calves to be processed for veal.

**CAUTION:** The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equines access to feeds containing Lasalocid as ingestion may be fatal. Mix thoroughly with grain and/or roughage prior to feeding, Feeding undiluted or mixing errors may result in an excess Lasalocid concentration which could be fatal to cattle and sheep. Do not feed to sheep or other copper-sensitive animals.
