This product is to be used as a cattle feed-through pesticide for the control of horn flies. All feed ingredients listed on this product label must adhere to the specifications and limits (if applicable) ascribed by the Food and Drug Administration (FDA) for the use of pesticides in cattle feed. This product contains ethoxyquin, a preservative.
