#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

#### ENVIRONMENTAL HAZARDS

This product is toxic to aquatic invertebrates. Using it in a manner other than that described by the label could result in harm to aquatic invertebrates. Do not contaminate water when disposing of rinsate or equipment wash waters.

#### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

#### FEEDING INSTRUCTIONS

When used as directed Co-op Supreme IGR Cattle Mineral-CTC 5675 will provide sufficient (S)-Methoprene insect growth regulator to prevent the emergence of adult horn flies from manure of treated cattle. Existing adult horn flies will not be affected. Start feeding before horn flies appear and continue use until cold weather marks the end of horn fly season. Assure cattle are not starved for nutrients in Co-op Supreme IGR Cattle Mineral-CTC 5675 by providing them with Co-op Supreme Cattle Mineral prior to feeding this mineral. Introduction of this product after an adult horn fly infestation is established will require treatment of cattle with adulticides if immediate elimination of the adult fly population is desired. For beef cattle weighing over 700 lb, hand feed this product at the rate of 0.28 oz per 100 lb of body weight per day to provide 0.5 mg of Chlortetracycline per lb of body weight per day and 29 mg of (S)-Methoprene per 100 lb of body weight per month. Do not exceed 3 mg of supplemental selenium per head per day. This feeding rate is Zinpro® verified to provide 360 mg of Zn and 12.6 mg of Co from Zinpro® products. Always provide plenty of clean, fresh water.

**WARNING:** A withdrawal period has not been established for this product in pre-ruminating calves. Do not use in calves to be processed for veal. This drug is not approved for use in female dairy cattle 20 months of age or older, including dry dairy cows. Use in these cattle may cause drug residues in milk and/or in calves born to these cows. No withdrawal period is required when used according to this label.

**CAUTION:** Federal law restricts medicated feed containing this Veterinary Feed Directive (VFD) drug to use by or on the order of a licensed veterinarian. This product contains high levels of copper. Consumption of this product by sheep, goats or other copper sensitive animals may result in copper toxicity.

**STORAGE AND DISPOSAL:** Do not contaminate water, food or feed by storage or disposal.

**Storage:** Store in a cool place.

**Pesticide Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
